DEFINITIONS OF TRUST POSITIONS

TRUSTEE: The person appointed, or required by law, to execute a trust; one in whom an estate, interest, or power is vested, under an express or implied agreement to administer or exercise it for the benefit. (Usually use a variation of your Upper/Lowercase "Name" Here. i.e: John Ray Doe or John R. Doe---this is not your Living Man.) CREATOR: The originator of the TRUST, appoints the TRUSTEE, SETTLOR & SUCCESSOR TRUSTEES. (This will be either Another 98 Trust OR a Variation of your Upper Lowercase Name again i.e. John Doe or INFINITY TRUST etc) SETTLOR: The grantor or donor in a deed of settlement, oversees the trust, even though in form the trust is created by another. (THIS IS SAME AS TRUSTEE)

SUCCESSOR TRUSTEE: A person that will assume TRUSTEE position when main TRUSTEE dies or resigns.
